The list will be e-mailed to you from the office of Joe Meyers & Assoc. and will be updated by them as we get closer to the actual sale date. If you desire some other form of the list please indicate on your return of the registration or contact our office. We must receive your current information and the fees so we complete the registration process before October 17, 2016.
